INTRODUCTION

The participation of people at the grassroots level is one of the cornerstones of the polder sustainability. Any polder has placed considerable emphasis on the development of two types of Field Level Institutions (FLI) - Water Management Groups (WMG) and Water Management Associations (WMA). Water Management Group (WMG) & Water Management Association (WMA) are the element of BWDB's national policy for participatory water management, whereby completed water infrastructure will be hand-over to community organizations for operation and maintenance. BWDB has drawn up Guidelines for Participatory Water Management (GPWM) by the Participatory Water Management Rules of 2014, Government of Bangladesh. The Government of Bangladesh has been rehabilitating and improving of 10 polers under 5 districts of Bangladesh. The formation of a Water Management Organization (WMO) will keep an essential role in the sustainability of Polder.

STATUS OF WMA AND WMG

sAccording to the policy of the GoB, work on WMO formation should begin before the commencement of civil works so that users are consulted during both design and implementation of the project and to ensure ownership and commitment to effective O&M. These consultancies had been delayed, but the five NGO contracts were awarded – three in February 2019 and two in April 2019, and work is completed. Earlier, it was planned to implement social afforestation through these same NGOs, however, considering sustainability/raising of the planned trees (which takes at least 10 years) after completion of the project, it was decided to carry out the task of planting trees through the Bangladesh Forest Department (BFD) with which MOUs have been executed. The World Bank has concurred with this changed arrangement.

The NGOs were involved in motivation and awareness raising of the local people towards afforestation program, group formation for the afforestation under social forestry rule, providing training to the participants and other stakeholders, exploring the suitable livelihood options for the participants etc. along with the other two (2) main tasks - i.e., Social Mobilization with Social Action Plan (incl. setting up WMOs) and Integrated Pest Management (IPM) Plan.

There were five consultancy packages for implementing the NGO services. Their contract signing date, services commenced date and office setup status are given below-

• **Package S01-A (Khulna District)** – Contract signed on February 24, 2019 and services commenced from March 18, 2019. Office was setup, one was at Khulna and another one was at Dacope.

• Package S01-B (Bagerhat District) – Contract signed on February 24, 2019 and services commenced from March 18, 2019. Office was setup, one was at Bagerhat and another one was at Sharonkhola.

• Package S01-C (Pirojpur District) – Contract signed on February 24, 2019. The Consultant has commenced the services from March 18, 2019. Office was setup at Bhanadaria.

• Package S01-D (Barguna District) – Draft Contract signed on 08 April, 2019. Contract signed on 02 May, 2019. Office was setup, one was at Barguna and another one is Patharghata.

• Package S01-E (Patuakhali District) – Contract signed on 02 May, 2019. Office was setup, one was at Galachipa and another one is Kalapara.

PURPOSE OF THE REPORT

Assessment of the functionality of the WMOs aims to pinpoint the status of the existing WMOs so that they can sustainably manage, operate, and maintain the water control structures for the benefit and equitable interest of the users. The review was carried out on the following aspects of the WMOs. And assess the functionality of Water Management Organization (WMO) in Works Package (WP)-01 and Works Package (WP)-02 under Coastal Embankment

Improvement Project Phase-1, field visits were conducted from 6th March to 13th March 2022 in WP-01 and from 22nd March to 27th March 2022 in WP-02.

1. Organizational Aspect: Executive Committees of WMG's and WMAs, Registration, Monthly meeting & Annual General Meeting, and the Planning and Decision-making process (including male and female participation), Minutes of meeting and office room.

2. Cooperative Aspect: Present Membership, shares and savings, and Income Generating Activities (IGAs).

3. Water Management Aspect: O&M Agreement Implementation (O&M works are being conducted), present issues/problems

4. Conflict Management: Factions in the village/WMG over water management issues.

METHODOLOGY

The following were the methodologies used for the assessment process:

- Conducted Focus Group Discussion (FGDs) with WMA and WMG Executive Committee members (male and female).
- Inspected books and minutes of meetings of the WMAs and WMGs.

OBSERVATIONS:

The key observations are summarized as follows:

Monthly Meeting

- Most of the Executive Committee's monthly meetings were not held regularly. If any meeting was held, no discussion agenda of the meeting was not shared with the EC members, and minutes of the meeting are rarely written and not kept in the record.
- The annual general meeting was not held yet in any WMA and WMG.

Fund Collection of WMA and WMG

• Mostly, the fund did not raise for WMA and WMG yet, except Polder 40/2 and 41/1 is in better condition. See the table below for fundraising status.

Need more training

During the implementation of the project, training was short and minimally awarded to the farmers.

Conflict with Muscle Man and Political Influence

In some polders as Polder 35/3, 33, 41/1, 43/2C, the muscle man and political power peoples have taken control the some sluice gates.

CONCLUSION AND RECOMMENDATIONS

- Communicating and networking with Bangladesh Water Development Board requires substantial improvement.
- Additional services (delivered by NGO or BWDB staff) may be needed to provide further support and guidance so that Executive Committee and General Assembly meetings are better organized and take place regularly, operation & maintenance plans and budget are developed and the required fees (cash or in-kind) are collected.
- Refresher training should be provided regarding roles and responsibilities.
